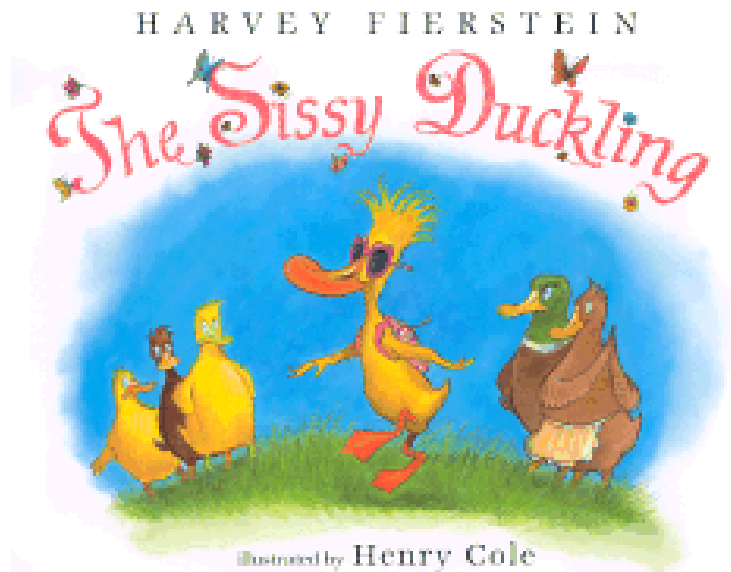
## About this Newsletter

It all starts with cute little books, colorful and attractive, like the one pictured below. *The Sissy Duckling*, written by actor and gay rights activist Harvey Fierstein, is intended for children ages 5 to 8 years old. It is the story of Elmer, who is "especially fond of decorating cookies" and goes to school with a pink backpack decorated with daisies. And when Elmer goes to the beach he likes to wear a pink bathing cap decorated with blue flowers. "Unfortunately, there wasn't a single other little boy duckling who liked to do ANY of the stuff that Elmer did. Not one." Get the picture?



This book is recommended in "GLBT Resources for Children: A Bibliography," prepared by Nancy Silverrod (San Francisco Public Library), of the "Gay, Lesbian, Bisexual, Transgendered Round Table" of the ALA (<http://isd.usc.edu/~trimmer/glbtrt/kidsbib.htm>).

*The Sissy Duckling* can be found by any child on the low shelves of the Children's Department of the Huron Library. CLEVNET (<http://www.cpl.org/>) has a total of 52 copies of this book. One of them is in the "Parenting" area of the Madison Main Library. The book is "*dedicated to proud sissies everywhere.*" How many 5 year-old "*proud sissies*" do you know?

Children are slowly being desensitized, starting with the *The Sissy Duckling*. Soon they will be reading *Boys and Sex*, by Wardell B. Pomeroy, Ph. D (Brace yourself: he also wrote *Girls and Sex*). Here is an excerpt of his great book:

3. *What would happen if a boy had intercourse with an animal?*

Among boys who practice it, intercourse with animals is usually infrequent, but there are case histories of boys who build up a strong emotional attachment to a particular animal and have intercourse with it whenever possible. This behavior is against the law in every state. There are severe penalties for violations, and social ridicule accompanies discovery. Nevertheless, records of such cases can be found in our history from colonial days to the present.

While intercourse with animals is known technically as bestiality, it also comes under the broader heading of sodomy, which more commonly means both homosexual intercourse and anal intercourse with a woman.

This kind of sexual behavior may never happen to you, because the incidence is so low. If it does, you would be best advised to keep any knowledge of it to yourself so you can avoid either ridicule or punishment, or both. You can feel secure in your knowledge that you're not a monster, no matter what society may think about it.

Pomeroy's advice to our boys is not to abstain from it, but to keep sex with animals, secret, so "*society*" will not think badly of them. Society, not parents. Should we stress the fact that bestiality should not even be mentioned in a book intended for minors? Pomeroy lives in San Francisco (imagine our shock) with his family. The *Publisher's Weekly Review* explains that Pomeroy "*makes a concerted effort to keep his text neutral and factual.*" We wonder if he gave pets to his children...

A total of 25 copies of this filth are available in the Children's and Youth Departments of our Public Libraries, one in the Library of Roxboro **MIDDLE** School.

Picture this: a parent goes to the Library with his child. The parent decides to access the Internet while his child safely –so he believes— goes to the Children's Department to look for a good picture book. Does any parent expect his child to find a picture book like "Stuck

“Rubber Baby” to read (see picture below)? Heck, no, but it is there, where it can be reached by any minor!



“Y’know one of the good things about **queer** [sic] sex, Les...? Nobody gets **pregnant** [sic].” Dialogue from *Stuck Rubber Baby*, by Howard Cruse (picture above). The Cleveland Main Library has three copies of this comic book, one in the Children’s Literature Department.



This beautiful, artistic picture (above) is from the book *Deal with it: a Whole New Approach to your Body, Brain, and Life as a Gurl*, by Esther Drill, Heather McDonald and Rebecca Odes. Among the useful topics discussed are: *Sex is Play*, *To Lose it or Not to Lose It*, *The First Time*, *Why Do Girls Like Girls?*, *Coming Out*. Topics also include how to perform anal sex, oral sex and group sex. The Young Adult Departments of Ohio Libraries have 28 copies (3 on order) of this deeply inspiring book available for your teen.

A picture book available to minors in the Sandusky Library is *Where did I Come From? The facts of life without any nonsense and with illustrations*, by Peter Mayle (picture below).



Here is how the author describes the female anatomy: “*These bumps have a lot of names. Some people call them the bosom. [...] Other people call them tities or boobs.*” Another explanation: “*The man pushes his penis up and down inside the woman’s vagina, so both the tickly parts are being rubbed against each other.*” CLEVNET owns a total of 44 books; 19 are in the Children’s Area. Although this book is from 1977, the Willoughby Hills Library has one on order.

To concerned parents who believe these clearly age inappropriate books should not be available to minors, the American Library Association responds that parents are the ones responsible for what their children read. How can a parent exercise control, when Libraries place trash on their lowest shelves, within reach of toddlers?

### **The ALA + gay, lesbian, bisexual & transgender Round Table**

Are you wondering why our Libraries have so many books charged with sexuality and homosexuality for children? The American Library Association (one of the best funded NGO’s in the US) has deep ties to lesbians, homosexuals, bisexuals and transgenders. While we could not care less about people’s sexual choices, non-heterosexuals at the ALA have earned our profound distrust in promoting literature for our youngsters.

### **Library.org, “Supporting Progressive Librarians since 1998”**

Among the links provided by Library.org is “*Social Responsibilities Roundtable of the ALA*” (<http://www.libr.org/SRRT/#taskforce>). This group believes “*libraries and librarians must recognize and help solve social problems and inequities in order to carry out their mandate to work for the common good and bolster democracy.*” So, choosing books is not enough, they need political activists. Every year its “Jackie Eubanks Memorial Award” awards “\$500 to an

*individual for outstanding achievement in promoting acquisition and use of alternative materials in libraries.”* And we all know what the meaning of “alternative materials” is... One of the projects Library.org supports is the “Friends of the Reference Center for Marxist Studies” (<http://www.libr.org/rcms>), a project to help the RCMS (<http://www.marxistlibrary.org/>) of NY “[to] regain possession” of documents of the Communist Party USA:

*CPUSA's papers were transported to the Soviet Union for safekeeping in the middle of the 20th Century and a microfilm copy was recently sold to the Library of Congress and to the publishing company IDC by the Russian Federation. Marxist ideals notwithstanding, the RCMS considers this an act of "stolen property."*

No word yet on when Library.org will start a project to catalogue and rescue materials referencing to the end of the communist regime...

### **GLBT Librarians and Library Workers Directory**

*“This directory includes names and contact information for gay, lesbian, bisexual, and transgendered librarians and library workers”*

(<http://www.ala.org/ala/glbtrt/welcomeglbtground.htm>). An Ohio library branch manager, listed in this directory, said his goal was *“Improving collections and services for GLBT users, particularly teens”* (bold emphasis added).

### **Who Supports the ALA?**

Discoverthenetworks.org (<http://www.discoverthenetwork.org>) is “a ‘Guide to the Political Left.’ It identifies the individuals and organizations that make up the left and also the institutions that fund and sustain it; it maps the paths through which the left exerts its influence on the larger body politic; it defines the left's (often hidden) programmatic agendas and it provides an understanding of its history and ideas.”

According to them (<http://www.discoverthenetwork.org/groupProfile.asp?grpId=6348>), the “ALA has received funding from: the Carnegie Corporation of New York; the Ford Foundation; the John D. and Catherine T. MacArthur Foundation; and the Rockefeller Foundation.” Also, “[a]s of March 2003, the ALA had spent \$1.7 million in fighting the implementation of [Children's Internet Protection Act] in the courts.” CIPA is the act that introduced filtering to Library computers.

How can we, parents, people who work for a living, fight against this tremendous enemy? If we do not unite for this fight, our words will simply hit the wall solidly built by the ALA in our Public

Libraries and Public School Libraries. We will accomplish nothing and our children will continue to be abused.

According to their Directors, Sandusky and Huron Libraries abide by the Children's Internet Protection Act (CIPA). What could be stopping them to apply the same standards to the selection of materials destined to minors? This brings us to the following question:

### Who are they working for?

**5.7 % of our Income Taxes are distributed to all Ohio Public Libraries**, yet you do not even have a say in the operation of your local Library. Since you are the one footing the bill, why are our local Libraries abiding by ALA and GLBTRT standards instead of their patrons'?

The Ohio Revised Code under "2907.31. Disseminating matter harmful to juveniles" specifies the following:

*(C) (1) It is an affirmative defense to a charge under this section, **involving material or a performance that is obscene or harmful to juveniles**, that the material or performance was **furnished or presented for a bona fide medical, scientific, educational, governmental, judicial, or other proper purpose**, by a physician, psychologist, sociologist, scientist, **teacher, librarian**, clergyman, prosecutor, judge, or other proper person (emphasis added)*

In other words, our laws are placing our children's innocent minds in the hands of any abuser or useful idiot with a mandate from the ALA and GLBT cohorts!

Let Ohio Libraries know what you think. Write our Representatives and ask them to help us bring Libraries back to local control –enough of State funding. Challenge your local Librarian to have public readings of parts of the books mentioned above (for more books write to us at: [grassroots@buckeye-express.com](mailto:grassroots@buckeye-express.com)). If you are tired of seeing our children being mentally abused, let us join forces and fight to end this insanity.

### UPPER ARLINGTON LIBRARY OFFERS GAY PAPERS IN LOBBY

*Outlook News* (<http://www.outlooknews.com/>) and *Gay People's Chronicle* (<http://www.gaypeopleschronicle.com/>) are two gay newspapers offered free in the lobby of the Upper Arlington Public Library, Columbus; both contain hardcore, pornographic material and are within reach of anyone, including minors who enter the Library. The area citizens are rightfully outraged: the Library Board of Trustees voted (6/0) to keep the papers –it seems the option of placing them behind the check out counter, was not considered.

One hundred people showed up at their last meeting with the Board (8/31/05); only 12 supported the Board. According to Dean Narciso, of the Columbus Dispatch, "As Carol Smathers read one passage, board members fidgeted and looked down. Others chewed pencils or shuffled papers." For example, the passage of page 28 of *Outlook News* (8/18/05),

*SPEAKING OF COMFORTABLE BOTTOMING: Isn't it supposed to hurt?' Well, no. Getting fucked may hurt, but it shouldn't. Think about it: that hole of yours painlessly*

*opens wide at least once a day, and rare is the man whose girth is greater than that of your daily doo."*

Gay People's Chronicle Personals, under *Bisexuals* reads: "[I] have a constant need for someone to climax in my mouth." Another looks for a "very submissive young slave bubble-butt bottom to serve me in all ways." Under *Gay Men* another ad explains that a GBM is looking for a "similar GWM ... with big, round protruding butt."

Narciso refers how Trustee John Burtch explained their decision: "We are a public library receiving tax dollars and have an obligation to provide materials and not censor those materials on a content basis." The response came from a man in the audience: "No more levies then!"

And this is the only argument they will hear: Public Libraries use our money to push homosexuality down our children's throats, we cut funding. Better: revert State to local funding. Only then will local patrons be in control of what their minors read in Libraries.
